Cookies are small text files stored on your device (such as your computer, tablet, or smartphone) when you visit our Site. You can learn more about cookies by visiting www.allaboutcookies.org. We may also use tracking pixels (pixel tags) within our website or marketing communications to understand engagement and improve relevance.

Managing Cookies

Most web browsers accept cookies by default, but you can adjust your settings to block or delete them. Disabling cookies may affect the functionality of our Site. Please refer to your browser's help section for detailed instructions.

Types of Cookies We Use

1. Strictly Necessary Cookies – Essential for you to move around the Site and use secure areas. Without them, certain services (such as logging in) cannot be provided. 2. Analytics Cookies – Help us understand how our Site is used, measure performance, and test improvements. Data is collected in an anonymised form wherever possible. 3. Functionality Cookies – Remember your preferences (e.g., language choice) and customisations to enhance your experience. 4. Social Media & Advertising Cookies – May be set by us or our partners to deliver advertising relevant to your interests and to measure the effectiveness of campaigns. 5. Performance Cookies – Help us monitor the Site's technical performance and ensure a smooth user experience.

MUID	Targeting	1 year 24 days	Microsoft cookie for advertising and analytics.
IDE	Targeting	1 year 24 days	Google DoubleClick cookie for ad relevance.
test_cookie	Targeting	15 minutes	Tests if a browser supports cookies.
calltrk_session_id	Analytics	1 year	Used by CallRail for tracking phone enquiries.
